HB 213 Moody | et al. Relating to the release on parole of certain inmates convicted of an offense committed when younger than 18 years of age; changing parole eligibility.

HB 249 Rogers | et al. Relating to a school security volunteer program in certain counties.

HB 459 Hull | et al. Relating to prohibiting the physical restraint of or use of chemical irritants on certain public school students by peace officers and school security personnel under certain circumstances.

HB 516 Wu | et al. Relating to requiring a school district or open-enrollment charter school to report data regarding certain disciplinary or law enforcement actions taken against students.

HB 655 Allison | et al. Relating to the placement by a school district of a student who engages in habitually violent behavior.

HB 1504 Johnson, Ann Relating to juveniles committed to the Texas Juvenile Justice Department.

HB 1626 Allen | et al. Relating to a public school student's transition from an alternative education program to a regular classroom and the admission of certain students with a criminal or disciplinary history.

HB 1898 Jetton | et al. Relating to a grant program to fund the provision by children's hospitals of mental and behavioral health services to children in this state.

HB 2237 Thompson, Senfronia Relating to the establishment of the child first grant program.

HB 2857 Dutton Relating to the removal of a public school student from the classroom for engaging in conduct involving the possession of certain prohibited substances.
