SB 539 Campbell

Relating to the manner in which an individual who has elected to defer collection of a tax, abate a suit to collect a delinquent tax, or abate a sale to foreclose a tax lien on the individual's residence homestead is listed on the delinquent tax roll of a taxing unit.

SB 561 Sparks

Relating to the authority of a political subdivision to issue debt to purchase or lease tangible personal property.

SB 572 Kolkhorst

Relating to the authority of a general-law municipality or county to regulate certain unlicensed residential facilities.

SB 1181 Miles

Relating to the right of the chief appraiser of an appraisal district, the appraisal district, or the appraisal review board of the appraisal district to bring certain claims in an appeal of an order of the appraisal review board.

SB 1998 Bettencourt

Relating to the calculation of certain ad valorem tax rates.

SB 1999 Bettencourt

Relating to the calculation of the unused increment rate of a taxing unit.

SB 2033 Kolkhorst

Relating to the allocation of certain federal money provided under the Cranston-Gonzalez National Affordable Housing Act.

SB 2035 Bettencourt

Relating to the issuance of certain anticipation notes and certificates of obligation.

SB 2350 Bettencourt

Relating to the voter-approval tax rate used to calculate the unused increment rate of a taxing unit for ad valorem tax purposes.

Relating to the provision of emergency services in Comal County Water Improvement District No. 3.

Relating to the text of municipal ballot propositions on the issuance of bonds.
